
The Committee, therefore, decided to take up these items first for consideration and decision.

	The Chairman informed the members that the Minutes are approved for circulation on 21.07.2021, action taken report shall be placed in the next meeting.
<b>ITEM NO.03</b>	<b>TO CONSIDER THE PRESENTATION BY THE SUB-COMMITTEE ON MANUAL OF ARCHITECTURAL PRACTICE ON VOLUME 1, 2 AND 3.</b>
	<p>The Chairman informed the members that as decided by the Executive Committee at its last meeting, the Sub-Committee on Manual of Architectural Practice would make a presentation online on the content of various Volumes of the Manual before the EC.</p> <p>The members of the Sub-Committee, namely, Ar. J. Manoharan, Convenor, Ar. Vijay Uppal, Member, Ar. P. Vaitinandin, Member, Ar. Sandeep Shikre, Member, Ar. Prashant Sutaria, Member, Ar. Salil Ranadive Member and Ar. N. Mahesh, Member, appeared before the Committee.</p> <p>The Convenor thanked the Chairman for giving him opportunity to be part the Manual Committee and briefed about the process followed the Sub-Committee in shaping the different volumes and 62 meetings held by the Committee for a minimum of three hours every Saturday. He informed that the Manual would have Five Volumes. Three volumes are ready, and the remaining two volumes will be finalized shortly. He also informed that the Three volumes were also sent to the Members of Review Committee namely, Ar. Vivek Gupta, New Delhi, Ar. N.V. Milana, Bangalore, Ar. Lalichan Zacharias, Kochi, Ar. V.Narsimhan, Bangalore and Ar. Jayprakash B. Agrawal, Kolkata. The Convenor also thanked Shri R. K. Oberoi, Registrar and Shri Deepak Kumar, AO, COA and other officials of the Council for being part of all deliberations of the Committee and making contribution wherever desired by the Committee.</p> <p>He further stated that the Manual was much awaited and was need of the hour as earlier documents were prepared in the year 2002. He introduced each and every member of the Committee to EC and requested the author each part of the Volume to briefly make the presentation of the respective parts.</p> <p>Ar. Salil Ranadive briefed the Executive Committee about the Volume 1. Ar. N. Mahesh and Ar. Prashant Sutarla brief about Volume 2. Ar. Sandeep Shikre briefed about Volume 3.</p> <p>Ar. Sandeep Shikre and Ar. Salil Ranadive also generally briefed the Committee on Volume 4 and Volume 5, respectively.</p>





	<p>Ar. P. Vaitinandin and Ar. Vijay Uppal also briefed the Executive Committee on efforts made for preparing the Manual.</p> <p>All the Members of the Sub-Committee thanked the Chairman, Vice-Chairman and EC Members for giving them opportunity to make their contribution for the cause of entire architectural fraternity.</p> <p>Ar. Kapil Setia, EC member, while appreciating mammoth task undertaken by the Sub Committee made following suggestions:</p> <ol style="list-style-type: none"> <li>1) Can /should timelines of diff. stages be suggested for different Scales of projects as in Clause 2.4.9.1. in Vol. 2 &amp; also under 3.8.3 in Volume 3 as a reference only.</li> <li>2). Similarly somewhere in the document we write Client &amp; Somewhere Promoter- let it be interpreted legally for its implications later.</li> <li>3). In para 2 of 2.1.4 – should the typology of projects be exhaustive like Urban Design, Conservation, Landscaping etc.</li> <li>4). What is full form of 'RFI' (on Pg.14.Vol.2)in para 2 of 2.2.4 ?</li> <li>5). The tabulation in 2.2.9 is unreadable..., the Content Writer should check this issue.</li> </ol> <p>The Sub-Committee on Manual assured that they would look into the issues pointed out by the Executive Committee.</p> <p>Ar. Ramesh Kumar, EC Member, stated that there is no mention of Govt. Architects in the manual. The Vice-Chairman clarified that a Sub-Committee under the Convenorship of Ar. Kapil Setia is preparing the model cadre structure for government architects and same will be incorporated in the manual appropriately.</p> <p>Ar. Bansan Singh Thangkhiew also appreciated the Three Volumes and stated that the Manual will greatly help the young Architects to understand the intricacies of the profession and to establish their practice.</p> <p>The Chairman, Vice-Chairman and other EC members appreciated the efforts made by the Convenor and other Members of the Sub-Committee and assured that they will make all efforts to ensure implementation of the contents of the Manual.</p> <p>With the above discussions, the Executive Committee approved the Three Volumes of the Manual.</p>

The Chairman informed the members that the Executive Committee in its previous meetings decided to carry out the interior work of the office of the Council at India Habitat Centre, Lodhi Road, New Delhi, to upgrade the look and feel of the office and to ensure proper utilisation of space and making appropriate seating arrangements for President, COA and other officers of the Council as well as to have separate meeting room. The task of preparing interior design was assigned to Ar. Vivek Gupta, New Delhi, who will carry out the work as pro bono for Council.

Ar. Vivek Gupta has prepared the detailed drawings and plans for carrying out the interior and shall make his presentation before the Executive Committee. After approval of the drawings/ plans a tender would be issued for appointment of a contractor for execution of the work.

The Executive Committee perused the drawings and plans prepared by Ar. Vivek Gupta and after having detailed deliberations the Committee approved the same and decided that a Tender be issued for engaging a contractor for carrying out the interior work.

The Executive Committee also decided that the cost of interior work be limited within Rs.50/- Lakhs to Rs.55/- Lakhs only.

	<p>The Chairman informed the members that Perspective Plan for Growth of Architectural Education was approved by the Executive Committee and Full Council and was implemented from the academic session 2021-2022.</p> <p>However, during the course of submission of applications by Architectural Institutions a need was felt for amendment in the same in view of certain inconsistencies in various zones.</p> <p>The Executive Committee discussed the matter in detail and was of the view that the clauses may hamper growth of architectural institutions and their financial viability.</p> <p>The Executive Committee, therefore, decided to modify the clauses as detailed below:</p>

- c. Institutions which were given approval earlier for a period of 2 or 3 years without inspection.





<b>I)</b>	<b>TO CONSIDER THE LETTER NO.3-2/2021-TS.VI DATED 27<sup>TH</sup> JULY, 2021 RECEIVED FROM MINISTRY OF EDUCATION, GOVT. OF INDIA, ADMISSION TO B.ARCH. COURSE THROUGH JEE AND CSAB.</b>
	<p>The Registrar-Secretary informed the members that the Council is in receipt of a letter no.3-2/2021-TS.VI dated 27<sup>th</sup> July 2021, from Shri Pawan Kumar, Under Secretary, Department of Higher Education, Ministry of Education, Govt.of India, regarding admission to B.Arch. course through JEE and CSAB conducted by National Testing Agency and requesting the Council to issue a notification modifying the admission criteria issued by COA or keep the present notification in abeyance for admission to SPAs, CFTIs and other institutions. He also invited the attention of the members towards letter dated 21.06.2021 written by SPA, New Delhi to Secretary, Department of Higher Education, Ministry of Education, in the matter.</p> <p>The Committee noted that as per Council of Architecture (Minimum Standards of Architectural Education) Regulations, 2020, passing NATA is mandatory for admission to B.Arch. Course. The Committee also noted that the Council has asked the institutions to admit only those institutions who has passed in NATA 2021.</p> <p>The Committee deliberated in the matter in detail and decided that the requirement of qualifying an aptitude test (i.e. NATA) conducted by Council of Architecture for admission into 1<sup>st</sup> year of 5 Year B.Arch degree course in terms of Council of Architecture (Minimum Standards of Architectural Education) Regulations, 2020 be kept in abeyance for SPAs and CFTIs, which give admission to students in the B.Arch Course on the basis of the JEE Examinations (JEE) and Central Seat Allocation Board (CSAB), for the academic session 2021-22. Accordingly, the Ministry be informed in the matter.</p>
<b>II)</b>	<b>TO CONSIDER THE LETTER NO.EXAM/110/2021 DATED 12<sup>TH</sup> JULY, 2021, RECEIVED FROM THE INDIAN INSTITUTE OF ARCHITECTS REGARDING CONDUCT OF ONLINE EXAMINATION BY THE COUNCIL FOR ASSOCIATE MEMBERSHIP OF IIA.</b>
	<p>The Chairman informed the members that Council is in receipt of letters dated 12.07.2021 and 02.07.2021 from the Indian Institute of Architecture forwarding the modalities for conduct of online IIA Examination proposed by the IIA for suggestion of the Council.</p> <p>He further informed the members that the Council has already appointed an Expert Committee to assess the infrastructure facilities and compliance made by IIA to comply with 2020 Regulations and IIA was asked to not to enroll any fresh candidates.</p>






However, no fresh student be enrolled till such time the inspect of IIA is completed by a Committee of Experts appointed by the Council.

The Executive Committee further decided that the Three Member Committee appointed by the Council shall also monitor the online examinations to be conducted by IIA for the existing candidates.

Accordingly, it is requested that the IIA may conduct the online exam for existing candidates and invited the Three Member Expert Committee of COA to monitor the same and make its report.
