ITEM NO.09

TO CONSIDER DISPOSING OFF FURNITURE AND FIXTURES OF COUNCIL AT CORE 4A, INDIA HABITAT CENTRE, LODHI ROAD, NEW DELHI.

The Registrar-Secretary informed the Members that the Council has taken on rent a space from IHC in Core 4A for its use since the year 2016. The same has been vacated on 31st July, 2022 and handed over to IHC. The furniture's & fixtures laying there were purchased in the year 2016 from previous tenant at the cost of Rs. 7,00,000/-. He also stated that IHC is interested in using the fixtures by refurbishing the same and has requested to leave the same as it is so that the same may be used by them.

The Executive Committee deliberated in the matter and decided that IHC may be communicated to make payment to the Council for fixture at a reasonable and mutually agreed price, so that the same may be written off from the books of accounts of the Council.

Registrar-Secretary, further informed that the fixtures removed from Core-6A office of the Council has been disposed off to the scrap vendor for Rs.45,000/, the furniture i.e. table and chairs purchased in the year 2019 has been retained by the Office for using the same.

TO TAKE NOTE OF THE SUCCESSFUL CONDUCT OF NATA 2022 EXAMINATION.

The Chairman informed the Members that the Council has been conducting National Aptitude Test in Architecture (NATA) every year for admission to First year of 5 year B.Arch. course.

The first test was held on 12th June, 2022 at 134 Centres in the country and 6 international centres out of 12,360 registered candidates, 11,074 candidates appeared in the test and 10, 080 candidates qualified the first test.

The second test was held on 07th July, 2022 at 137 Centres in the country and 6 international centres. Out of 15,634 candidates 13,829 appeared in the second test and 13,109 candidates qualified in the second test.

The third test was held on 07th August, 2022 at 137 Centres in the country and 7 international centres. Out of 17,981 registered candidates 12576 candidates appeared in the third test and 11,799 candidates qualified in the second test.

Thus, for the academic session 2022-23, 22,600 unique candidates appeared in the NATA 2022 test and 21,540 candidates qualified the test.

The Executive Committee noted the information and expressed their concern over decrease in number of Unique candidates for admission to B.Arch. course.

The Executive Committee after deliberations desired that a study be undertaken on the reasons of falling number of candidates for admission to B.Arch. course.

DESAI, CONTROLLER OF EXAMINATIONS, INDIAN INSTITUTE OF ARCHITECTS, MUMBAI, REGARDING CONDUCT OF ASSOCIATE MEMBERSHIP OF IIA BY EXAMINATION.

The Registrar-Secretary informed the members that the Council is in receipt of a letter dated 10.08.2022, in response to Council's letter dated 11.06.2022. The Executive Committee considered the letter dated 10.08.2022, received from Shri R. K. Desai, Controller of Examinations, IIA, in response to Council's letter dated 11th June, 2022.

The Executive Committee noted that the Council vide its letter dated 11.06.2022, has sought an action plan for implementing the recommendations of the Review Committee constituted by the Council in order to verify the maintenance of the minimum standards by IIA. However, the IIA, except for stating that syllabus of the examination is already approved by COA and any revision to the syllabus by COA shall be implemented, has not submitted any action plan to the Council.

The Executive Committee after detailed discussions in the matter noted that the syllabus of the IIA examination approved in the year 2014, must be aligned with COA Minimum Standards of Architectural Education Regulations, 2020.

Further, the Executive Committee after deliberating on the recommendations/ report of the Review Committee of Council and IIA letter dated 10.08.2022, decided that the IIA must comply with the following requirements in order to continue to confer a recognized qualification under the Architects Act, 1972:

- Fixing contact hours of study in every course/ subject in online or offline mode.
- Review of every design and building construction work by a faculty member, at least two times in course of a Semester. A guide/ mentor shall monitor the design evolution for every studio project.
- Preparation of Academic Calendar duly marking all dates of contact classes, reviews, exams, etc.
- 4. Peer interaction and group discussions in online/ offline mode.
- 50% marks shall be allotted for Internal Assessment i.e. for Tests, Quiz, written assignments, etc. as required by the natures of course, as per 2020 Regulations.
- 6. Each candidate shall submit a report in a stipulated format, indicating the type of projects he/she is working on and the nature of work done by him/her. A half- yearly report shall be submitted by each candidate. The report shall be countersigned by the supervising architect.
- The criteria for selection/ appointment of faculty members for giving academic inputs, preparation regarding study material and question papers shall be as per COA's MSAER 2020 Regulations.
- 8. The process being following by IIA for conducting exams and granting Associate Membership shall be subject to an annual review by COA, before the start of every academic year and admitting

Further, in view of the implementation of NEP by Government of India, the IIA has to prepare and submit a roadmap to Council as to how it will comply with the same in order to continue to confer a recognized architectural qualification.

The Executive Committee further decided that IIA be once again asked to submit an action plan for implementing the above requirements/ minimum standards within a month from the date of receipt of this letter.
