The Chairman welcomed the members attending the meeting and thanked them for sparing their valuable time.

## ITEM NO.1 CONFIRMATION OF THE MINUTES OF THE 184<sup>TH</sup> AND 185<sup>TH</sup> MEETING OF THE EXECUTIVE COMMITTEE OF THE COUNCIL OF ARCHITECTURE.

The Chairman informed the members that the Minutes of 184<sup>th</sup>, 185th and 186<sup>th</sup> Meeting will be circulated to members in due course.

## ITEM NO.2 TO CONSIDER THE DELHI HIGH COURT ORDER DATED 25.04.2018, IN THE MATTER OF W.P.(C) 934/2012 SUDHIR VOHRA VERSUS REGISTRAR OF COMPANIES AND ORS AND OTHER CONNECTED MATTERS.

The Chairman informed the members that Hon'ble Delhi High Court (Single Judge Bench) vide order dated 25.04.2018, in the W.P. (C) No.934 of 2012 in Sudhir Vohra v. Registrar of Companies & ors and other connected matters, has held that the Architects Act, 1972 restricts only use of title and style of Architect to natural persons. Non-architects and juridical entities / companies can provide architectural services. The members perused the order dated 25.04.2018 and deliberated threadbare on the same.

The Chairman invited one Advocate Shri D.S. Mahendru for his presentation on the above matter before members. Advocate informed the members that the order can be challenged before Division Bench and it could go upto Supreme Court for final adjudication.

The Committee authorized the Chairman to take a final decision for appointing advocate for filing an Appeal before the Division Bench of the High Court challenging the order of Ld. Single judge.

## ITEM NO.3 TO CONSIDER LEGAL VETTING OF THE AMENDMENTS PROPOSED BY THE COUNCIL IN THE ARCHITECTS ACT, 1972.

The Chairman informed the members that the Council at its 68<sup>th</sup> Meeting held on 13<sup>th</sup> and 14<sup>th</sup> April, 2018, considered the proposed Comprehensive Amendments to the Architects Act, 1972 and authorized the President to finalise and submit the proposed amendments to the Ministry of HRD for further action.

The Chairman proposed that before submitting the proposed amendments to the Ministry the same may be got vetted from an experienced advocate.

The Committee deliberated in the matter and authorized the Chairman to appoint an experience advocate for vetting and finalizing the amendment proposal from all aspects.
