The Executive Committee noted that the Chairman, Executive Committee has granted approval to some institutions, namely, BKPS College of Architecture, Pune; Chanakya College of Architecture, Raipur and one institution namely Lingaya University, Faridabad was issued show cause notice for reduction of intake from 20 to 0 in the M.Arch. course for conducting classes on week days in regular course.

The Executive Committee approved and ratified the action taken by the Chairman, Executive Committee.

ITEM NO. 10 TO CONSIDER REQUESTS RECEIVED FROM INSTITUTIONS IMPARTING B.ARCH COURSE FOR CLOSURE OF INSTITUTION(S) FROM ACADEMIC SESSION 2018-19.

The Executive Committee perused the requests received from 2 institutions namely UP14 Shri Bake Bihari Institute of Meerut and RJ19, U.S.I Institute of Architecture, Chittorgarh for closure of their institutions.

The Committee noted that UP14 Shri Bake Bihari Institute of Meerut has requested the Council for transfer of students to other institutions and has also deposited the requisite fees of Rs. 5 lakh for closure.

The Executive Committee further decided that the students, if any, admitted by the Institutions till the academic session 2017-2018 and granted enrolment number by the Council be transferred to other institutions affiliated to the same University with which the said institution was affiliated.

Further, any students who desire to take transfer/admission in institutions of their choice at their own level, may be allowed to do so, within the intake sanctioned by the Council to the respective institutions. No specific approval/permission letter from the Council is required by any institution/authority in the country for transfer of these students and this letter may be treated as necessary permission in the matter.

The Executive Committee approved for the closure of these institutions.

ITEM NO. 11 TO CONSIDER THE LETTER DATED 20TH JUNE, 2018 RECEIVED FROM REGISTRAR, JAWAHARLAL NEHRU ARCHITECTURE AND FINE ART UNIVERSITY, HYDERABAD REGARDING ADMISSION OF CHILDREN OF INDIAN ORIGIN LIVING/ WORKING ABROAD IN THE FIRST YEAR OF 5 YEAR B.ARCH. DEGREE COURSE.

The Executive Committee perused the letter dated 20th June, 2018, received from Registrar, Jawaharlal Nehru Architecture and Fine Art University, Hyderabad, requesting the Council for grant of supernumerary seats over and above the sanction intake, under foreign National/Non-Residents Indian/ Children of workers in gulf countries categories.

The Executive Committee deliberated in the matter and noted that the Council is sanctioning intake for all categories within the sanction intake only except for Jammu & Kashmir migrants and supernumerary quota of Central Government in Central Government institutions.

The Committee further noted that the intake is sanctioned with reference to requirement to faculty, land, building, studios, laboratories etc. Hence, the intake for foreign Nationals/NRI's cannot be sanctioned over and above the sanctioned intake. The Institution must admit these students within the sanction intake only. However, the institution, if it may so desire apply for additional intake from Council.

ITEM NO. 12 TO CONSIDER THE LETTER NO. B.ARCH/76/2018-19 DATED 11TH JULY, 2019 RECEIVED FROM PRINCIPAL-IN-CHARGE BKPS COLLEGE OF ARCHITECTURE, PUNE, REGARDING GRANT OF CONCESSION IN QUALIFYING MARKS FOR CANDIDATES BELONGING TO RESERVE CATEGORY FOR RECRUITMENT TO FACULTY POSITION IN ARCHITECTURAL INSTITUTIONS.

The Executive Committee considered the letter No. B.Arch/76/2018-19 dated 11th July, 2018 received from Principal-in-Charge, BKPS College of Architecture, Pune, regarding UGC regulations dated 11th July, 2016, providing concession upto 5% in qualifying marks for candidate belonging to SC/ST/Differently Abled /OBC Category, duly enclosing copy of UGC Regulations.

The Executive Committee perused the Regulations as framed by UGC and decided that the same may be accepted for recruitment of faculty in Architecture Institutions. Accordingly, the Principal-in-Charge, BKPS College of Architecture be informed.

ITEM NO.13 TO CONSIDER THE REPORT OF THE EXPERT COMMITTEE APPOINTED BY THE COUNCIL FOR CONDUCTING VIVA-VOCE OF THE STUDENTS OF B.ARCH. COURSE ADMITTED IN THE YEAR 2011 IN SCHOOL OF ARCHITECTURE, NOIDA INTERNATIONAL UNIVERSITY, GREATER NOIDA, U.P.

The Executive Committee perused the Report dated 11th June,2018 submitted by the Expert Committee comprising of Dr. Raja Prakash Purshottanam and Ar. Rajendra Kumar, who conducted viva-voce of the students who have undergone bridge course as suggested by the Council as they were admitted to the first year of B.Arch. course without valid approval.

The Executive Committee perused the Report of Expert Committee and decided that the 13 candidates be granted enrolment number and registration by the Council of Architecture as they have undergone a recognized qualification as per norms of Council.

ITEM NO.14 TO CONSIDER THE REPRESENTATIONS RECEIVED FROM STUDENTS WHO COULD NOT QUALIFY THE FIRST STAGE EXAMINATION CONDUCTED BY THE COUNCIL OF ARCHITECTURE FOR GRANTING ENROLMENT AND REGISTRATION AS AN ARCHITECT.

The Executive Committee noted that the Council in the year 2014 had conducted first stage examination of the students admitted by several institutions without valid approval of the Council in the first year of 5 year B.Arch. degree course.

While majority of the students passed the first stage examination, 37 students could not pass this examination and further no chance/ attempts could be provided to them as no such test was not conducted later on. In the meantime, these students have completed their 5 year B.Arch. degree course and are now representing to Council to grant them enrolment number and also register them as an Architect.

The Executive Committee noted that as these students have already completed their degree course and as no further test could be imposed on such students, they may be granted enrolment number and registered as an Architect subject to their meeting with other requirement are prescribed for registration as an Architect.

ITEM NO.15 TO CONSIDER E-MAIL DATED 17.07.2018 RECEIVED FROM AR. BINUMOL TOM REGARDING SUPPORT TO PRESENT PAPER AT AN INTERNATIONAL CONFERENCE IN PORTUGAL, COIMBRA.

The Executive Committee perused the e-mail dated 17th July, 2018 received from Ar. Binumol Tom, Kerala, requesting the Council to sponsor her registration fee for presenting her paper at Biennial Conference in Portugal.

The Executive Committee considered the matter in detail and noted that though the Council in the past had granted some token amount to faculty Members of Architectural Institutions for presenting thesis/papers abroad, however, as Ar. Binumol Tom is working in a Government College and eligible to seek support from the concerned Government her request cannot be considered.

Further, Executive Committee noted that the Council has not laid down any specific Budget Head for sanctioning such amounts to faculty Members of Architectural Institutions. Accordingly, she may be informed of the decision of the Executive Committee that it is not possible for Council to sponsor her candidature for the conference at Portugal.

ITEM NO.16 TO CONSIDER THE LETTER NO.34/56/2015-TPD(SERVICES) FTS DATED 30.05.2018, RECEIVED FROM ADDL. ECONOMIC ADVISER/DIRECTOR DEPARTMENT OF COMMERCE, MINISTRY OF COMMERCE & INDUSTRY, GOVT. OF INDIA, W.R.T. COUNCIL'S LETTER DATED 27.04.2018.

The Executive Committee perused the draft rules and decided that the same be circulated to all Members of the Council for seeking their views in the matter.

ITEM NO. 17 TO CONSIDER THE APPOINTMENT OF ANOTHER STENOGRAPHER IN THE OFFICE OF THE COUNCIL.

The Registrar-Secretary informed the Members that the Council is having one post of Stenographer and one Senior Stenographer in the Council. The advertisement was given for both the posts. The post of Stenographer has been filled up after due process, however, no suitable application were received for the post of Senior Stenographer.

As the Council urgently requires services of another Stenographer for carrying out routine and urgent work by the President and Registrar of the Council as well as to handle their office, visitors, phone calls, records and appointments etc. a suitable candidate from out of the merit list of candidates who passed the examination for the post of Stenographer may be selected.

The Executive Committee deliberated detail in the matter and authorized the president to take appropriate action in the matter.

ITEM NO.18 TO CONSIDER EXTENSION OF ENGAGEMENT OF SERVICES OF SHRI MASTER AKASHDEEP AS RESEARCH ASSOCIATE, TRC BHUBANESWAR.

The Executive Committee noted that Shri Master Akashdeep, was appointed as Research Associate in Training and Research Centre, Bhubaneswar for a period of 6 months on a consolidated salary of Rs. 50,000/- per month. His 6 month term has expired ended on 3rd July, 2018.

The Executive Committee decided that in order to continue the activities of TRC, Bhubaneswar and till a regular Research Associate is recruited, the appointment of Master Akashdeep, may be extended for a further period of 6 months on contractual basis on the same terms and conditions.

The Executive Committee also decided that the process for recruitment of Research Associate on regular basis be initiated at the earliest.

ITEM NO.19 TO CONSIDER EXTENSION OF ENGAGEMENT OF SERVICES OF SHRI C.B.MISHRA, AS SENIOR CONSULTANT IN COUNCIL OF ARCHITECTURE.

The Executive Committee noted that tenure of Shri C.B.Mishra, working as Senior Consultant in the Council of Architecture will be ending on 31st July, 2018 and also that as per official records Shri Mishra has attained the age of 60 Years on 21.03.2018.

President informed the Members that presently Shri Mishra is handling various important assignments including liaisoning with various Government agencies for allotment of land for the proposed TRC's of the Council and appraised that the performance of Shri Mishra was found to be quite satisfactory during the past one year. Further, he pointed out that in Central Government there is provision of engaging professional consultants on contractual basis up to the age of 65 years.

The Committee after detailed deliberations in the matter decided that the engagement of Shri C.B Mishra be extended as a professional Senior Consultant for a period of further 6 months on the same monthly consolidated remuneration of Rs.1 Lac.

ITEM NO.20 ANY OTHER ITEM WITH THE PERMISSION OF THE CHAIR.

No other item was discussed.
