Therefore, the Committee decided that in absence of original report, matter cannot be considered till such time original report is traced and placed on record. Thus, the Minutes as recorded in the 199<sup>th</sup> Meeting of the Executive Committee are correct and no modification of the Minutes is required.

The Executive Committee perused the Budget estimates of the Council for the financial year 2019-20, Recurring expenses Rs. 18,61,19,250(Rupees Eighteen Crores Sixty One Lakhs Nineteen Thousand and Two Fifty only) and non-recurring expenses of Rs. 14,60,00,000/-(Rupees Fourteen Crores and Sixty Lakhs only)Total Rs.33,21,19,250/-(Rupees Thirty Three Crores Twenty One Lakhs Nine Thousand and Two Hundred and Fifty Only) along with probable income receivable to the time of Rs. 33,21,36,800 (Rupees Thirty Three Crores Twenty One Lakhs Thirty Six Thousand and Eight Hundred Only) during financial year 2019-20, as annexed with agenda.

The Executive Committee perused the various communications exchanged regarding the appointment of Research & Associate and office Assistant at COA-TRC office at Bhopal and decided that presently there is no need for appointment of any Research Associate at COA-TRC, Bhopal and an office Assistant may be appointed by the Council after following the due process to assist the Honorary Director in carrying out the work of TRC. Further, Ar. Alok Ranjan, Member was requested to prepare a proposal on staff strength in COA-TRCs.

# ITEM NO.8 APPOINTMENT OF MINISTERIAL STAFF ON CONTRACTUAL BASIS IN THE COUNCIL.

The Chairman informed the Members that the regular appointment of staff for vacant positions in the Council have been put on hold due to Parliamentary Elections. Hence, it was decided to invite suitable candidates from New Delhi, YMCA on contractual appointment for a period of 6 months to carry out the work load in Council.

The candidates were informed to appear before the Executive Committee for interview/skill test to decide their suitability of appointment in the Council of Architecture.

About 5 candidates appeared before the Executive Committee and the Executive Committee found 3 candidates suitable for working as trainee/ secretarial assistant for the period of 6 months on contractual basis on a remuneration of Rs.17,500/- for the candidates having undergraduate qualification and Rs.15,000/- per month to the candidate pursuing undergraduate qualification.

#### ITEM NO.9 TO CONSIDER INFORMATION ON ISSUANCE OF ROLL NO. FORMAT, DRAWING SCANNING AND EVALUATION PLAN FOR NATA 2019 EXAMINATION.

The Executive Committee perused the format of NATA 2019 Roll Numbers and also perused the list of evaluation centres for NATA 2019 examination and approved the same.

#### ITEM NO.10 ANY OTHER ITEM WITH THE PERMISSION OF THE CHAIR.

#### I) ISSUANCE OF TWO MARKSHEETS IN NATA 2018 EXAMINATION TO MS. SAHAJ PREETI, PRESENTLY ADMITTED IN B.ARCH. COURSE IN DYAL BAGH UNIVERSITY, AGRA.

The Executive Committee noted that Ms.Sahaj Preeti, Student, Dyal Bagh University, Agra, was admitted to the B.Arch. course based on mark sheet issued by TCS last year wherein her result was shown as "qualified" and a letter on a revised mark sheet was also issued to her then her result was showed fail.

The Executive Committee after deliberations in the matter noted that in view of the issuance of 2 mark sheets/score card to the candidate in one declaring her as "qualified" and in another as "failed", she may be afforded one more opportunity to pass the aptitude test for continuing her education in the B.Arch. course. Therefore, she should appear in the NATA 2019 examination and qualify the same to continue her admission in the B.Arch. course.

The Executive Committee decided that the decision of the Council informed to the Institution as well as the Candidate.

#### II) TO CONSIDER THE REPRESENTATION OF MR. IMRAN KHAN, A STUDENT OF R.V. COLLEGE OF ENGINEERING, BENGALURU, REGARDING CANCELLATION OF HIS ADMISISON BY KARNATAKA EXAMINATION AUTHORITY.

The Executive Committee perused the email dated 21.03.2019 of Dr. O.P. Bawane, Principal, R.V. College of Engineering Bengaluru, along with the representation of Mr. Imran Khan, a student of B.Arch. course in the R.V.College of Engineering, Bengaluru, and noted that though the candidate was allowed by the Karnataka Examination Authority, however, they failed to take note of the fact that the Candidate was not qualified in the NATA examination and later on cancelled his admission after the candidate, has appeared in the first semester examination of the B.Arch. course.

The Executive Committee deliberated in the matter in detail and decided that in order to protect the interest of the candidate and as one time measure without any future precedence he may continue his studies in B.Arch. course subject to his passing the NATA 2019 examinations. If he failed to pass the NATA 2019 examination he be not allowed to continue in the B.Arch. course.

### I) TO CONSIDER THE DRAFT TENDER DOCUMENT FOR APPOINTMENT OF CONTRACTOR FOR INTERIOR WORK OF OFFICE SPACE OF THE COUNCIL AT NBCC PLACE, OKHLA, NEW DELHI.

The Executive Committee perused the draft tender document as prepared by Architect Ameet Babbar, for appointment of a Contractor for carrying the interior work of office space of the council at NBCC Okhla.

After perusing the document the Executive Committee decided that the Architect be asked to prepare the Stage 1 estimate for the entire work and thereafter the tender may be issued.
