Sub:- Amendment/ Relaxation in B.Arch. Eligibility Criteria for academic session 2023-2024 – reg.

Dear Sir/Madam,

The Council of Architecture, with the approval of the Central Government, has amended / relaxed the eligibility for admission to 1st year of 5-year B.Arch. Degree Course as prescribed under Regulation 4 of the Council of Architecture (Minimum Standards of Architectural Education) Regulations 2020, for the academic session 2023-2024. The amended eligibility is stated as under:


“(1) No candidate shall be admitted to architecture course unless she/he has passed 10+2 or equivalent examination with Physics and Mathematics as compulsory subjects along with either Chemistry or Biology or Technical Vocational subject or Computer Science or Information Technology or Informatics Practices or Engineering Graphics or Business Studies with at least 45% marks in aggregate or passed 10+3 Diploma Examination with Mathematics as compulsory subject with at least 45% marks in aggregate.”

(Note : The above relaxation shall be valid for the admission in academic session 2023-2024 only, irrespective of the year in which a candidate has passed 10+2 or 10+3 examination.)

“(2) The candidate needs to qualify an aptitude test in architecture conducted either by NTA (i.e. JEE) or “NATA” conducted by the Council of Architecture.”

The same has been published in the Official Gazette of India on July 19, 2023 and has come into effect from the date of publication in the Gazette. A copy of the said notifications is attached herewith for your ready reference.

As per the above Regulations, the institutions shall give weightage of 50 per cent. marks for aptitude tests and 50 per cent. marks in the qualifying examination for admission into B.Arch. course. The reservation of seats and relaxation in percentage of marks obtained in the qualifying examination for admission of the candidates belonging to reserved categories shall be as per the reservation policy of Central Government or the respective State Governments.

It may be further stated that the classes for 1st year 5-year Architecture degree course shall not commence later than the 1st working day in the month of September, 2023 and all admissions must be completed before the said date.

In view of the above, all the admission authorities, universities and institutions imparting B.Arch. degree course in the country are required to follow the above eligibility criteria for admission into 1st year of 5-year B.Arch. degree course **for the academic session 2023-2024.**

(2) ये राजपत्र में प्रकाशन की तिथि से लागू होंगे तथा केवल अकादमिक सत्र 2023-2024, के लिए लागू होंगे, जिसके उपरान्त मूल विनियम जो कि 11 अगस्त, 2020 को प्रकाशित हुए हैं लागू हो जायेंगे।

 - कोई भी अभ्यर्थी जिसने 10+2 परीक्षा प्रणाली में भौतिकी तथा गणित अनिवार्य विषयों के साथ-साथ रसायनशास्त्र अथवा जीवविज्ञान अथवा तकनीकी व्यवसायिक विषय अथवा कम्प्यूटर विज्ञान अथवा सूचना प्रौद्योगिकी अथवा सूचना विज्ञान अभ्यास अथवा अभियांत्रिक ग्राफिक्स अथवा बिजिनिस स्टडीज के साथ कुल प्राप्तांक 45 प्रतिशत से उत्तीर्ण न की हो अथवा 10+3 डिप्लोमा परीक्षा गणित अनिवार्य विषय के साथ कुल प्राप्तांक 45 प्रतिशत से उत्तीर्ण न की हो, को वास्तुकला स्नातक पाठ्यक्रम में प्रवेश नहीं दिया जायेगा।

F. No. CA/498/2023/MsAE(Regulations).—In exercise of powers conferred by clauses (e), (g), (h) and (j) of sub-section (2) of Section 45 read with Section 21 of the Architects Act, 1972 (20 of 1972), the Council of Architecture, with the approval of the Central Government, hereby makes the following Regulations to further amend the Council of Architecture (Minimum Standards of Architectural Education) Regulations 2020, the same having been published in the Gazette of India, Part-III-Section-4 dated the 11th August, 2020, namely: -

1. (1) These Regulations may be called the Council of Architecture (Minimum Standards of Architectural Education) (Amendment) Regulations, 2023.
- (2) They shall come into force from the date of this publication in the official Gazette and shall be applicable for the academic session 2023-2024 only and thereafter the original Regulations as notified in the Gazette on 11.08.2020 shall be in force.
2. In the Council of Architecture (Minimum Standards of Architectural Education) Regulations, 2020, in Regulation 4 for sub-regulation (1) the following sub-regulation shall be substituted, namely:-

“(1) No candidate shall be admitted to architecture course unless she/he has passed 10+2 or equivalent examination with Physics and Mathematics as compulsory subjects along with either Chemistry or Biology or Technical Vocational subject or Computer Science or Information Technology or Informatics Practices or Engineering Graphics or Business Studies with at least 45% marks in aggregate or passed 10+3 Diploma Examination with Mathematics as compulsory subject with at least 45% marks in aggregate.”
