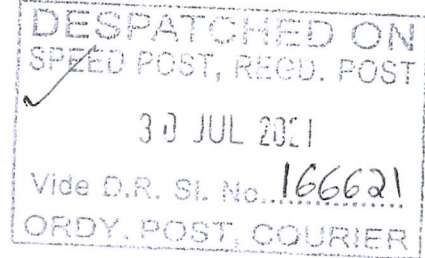

I am directed to refer to your letter No. Exam/106/2021 dated 02.07.2021 and letter No. Exam/110/2021 dated 12th July, 2021, on the above subject.


In this regard, it is informed that the matter was placed before the Executive Committee of the Council at its 229th Meeting held on 28th July, 2021. The Executive Committee decided that IIA may go ahead with conduct of online examinations as per the Policy of the Council circulated earlier to Architectural Institutions (copy attached herewith for ready reference) for existing candidates enrolled by IIA for Associate Membership of IIA (By Examination). However, no fresh students be enrolled till such time the review and inspection of IIA for conduct and grant of Associate Membership of IIA (By Examination) is completed by the Fact-Finding Committee appointed by the Council.

The Executive Committee further decided that the same Fact-Finding Committee shall also observe and monitor the online examinations to be conducted by IIA for the existing candidates.

Accordingly, it is requested that the IIA may conduct online exam for existing candidates and invite the three-member Expert Committee of COA to observe and monitor the same.
