8. Any defect arising during the warranty period shall be rectified within 48 hours of complaint registration, failing which appropriate action may be taken as deemed fit.
9. Only new, unused, and genuine products shall be supplied. Refurbished or second-hand items will not be accepted.

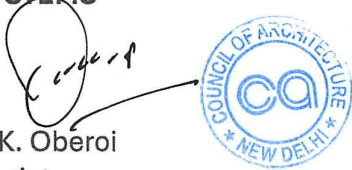
10. **The bidder may quote one or more models, clearly indicating the make and model for each item.**
11. Delivery shall be completed within 7 days from the date of award of contract. Installation and commissioning shall be carried out at site without any additional cost.

13. Payment shall be released within 10 days after successful delivery, installation, and acceptance of the goods by the Council.
